21	Mr. Dorrill offered an invocation, and the Pledge was recited in unison.

23	A. Public Comment	
24	No public comment was received at this time.	
25		
26	ROLL CALL/APPROVAL OF AGENDA	
27	All Board members were in attendance at the meeting.	
28	The following items were added to the Agenda: 7A, Security Follow up; 7B, Grand Lely	
29	Roundabout; 7C, Mosquito Spraying; 7D, Update on Traffic Study; 7E, Parking Lot Update;	
30	7F, Post Office box; 7G, July 10 meeting; 7H, Irrigation at Lakoya, and 7I, Update on Inspira.	
31	Item 4E, Hurricane Follow-up Items was added by Mr. Dorrill.	
32	With those additions, the Agenda was unanimously approved on a MOTION by Mr. Drum and	
33	a second by Mr. Lee.

35	APPROVAL OF MAY 2019 MINUTES	
36	As it relates to the Budget Workshop, the minutes were unanimously approved on a MOTION

- 5 by Mr. Lee and a second by Mr. Ousley.
- As it relates to the regular meeting minutes, on Page 4, Line 31, the discussion was on FalconsGlen.
- 8 On a MOTION by Mr. Ousley and a second by Mr. Lee, the regular meeting minutes as
- 9 amended were unanimously approved by the Board.
- 10

11 MANAGER'S REPORT

- 12 A. Community Patrol for May
- 13 This monthly report included 57 various incidents including nine trespass violations as it relates
- 14 to fishing in rear yards, all of which were non-residents. There were six vandalism or
- 15 maintenance issues reported, and five suspicious incidents, most of which were referred to law
- 16 enforcement.
- 17 There were 18 traffic assists, and aside from one turtle, there were no animals reported. Mr.
- 18 Bowers elaborated on the hit and run report, which was vehicular, and the culprit was not
- 19 located. Mr. Bowers also noted that a brush fire started by a lightning strike occurred near a
- 20 home, and Alvin, who was on duty, called 911 and it was quickly taken care of. Both Mr.
- 21 Bowers and the second shift officer, Alvin, have law enforcement backgrounds.
- 22

23 <u>B. Round Up</u>

- 24 Mr. Campkin asked that this item be put on the agenda as a forum for any resident to express
- their concerns as it relates to the information coming out on Round Up following the two
- 26 California lawsuits.
- 27 Throughout the world Round Up is used for the successful growth of corn, wheat and barley,
- among others. The ornamental use of Round Up has been ongoing at Lely for a long time. At
- 29 this time there have been no findings from the regulating Federal sources, both the EPA and the
- 30 US Health Service and centers for disease control that would discourage its use. Several
- 31 progressive communities, such as Sanibel and Miami Beach, have passed resolutions to attempt
- to reduce the amount of Round Up in their horticultural maintenance programs.
- 33 Mr. Dorrill suggested that the Board listen to the concerns that people have, and if it is their
- 34 inclination, a workshop can be held this fall.
- 35 The University of Florida has a nationally recognized Institute of Food and Agricultural Sciences
- 36 which is an independent source of information, and would be an excellent source of
- 37 information on this topic. Their offices are part of the State Government and are located in all
- 38 67 counties in the State.

- 5 Mr. Campkin then asked for input from those present.
- 6 Mr. Lee indicated that as it relates to CDD use, two ounces of Round Up is mixed with a gallon
- 7 of water, and is administered only by a licensed individual. Each individual community is
- 8 responsible for their own landscaping, and it is their decision as to what they use.
- 9 Dr. Bularzik noted that Bob Cook was brought in to speak to the Lely Presidents Group in June,
- and gave them a report on Round Up, and she provided copies of his information for anyone
- 11 who was interested. She also offered to email it to anyone who wished to receive it.
- 12 Dr. Bularzik also offered to send the report Mr. Dorrill referred to from the University of Florida,
- 13 which also provides quite a bit of information.
- 14 Mr. Drum advised that a resident who lives on the lake observed an employee of the District
- 15 spraying the lake bank, and residents on the golf course observe spraying going on there as
- 16 well. Mr. Drum asked what type of chemicals they were using, and Mr. Vanover advised that
- 17 there are different chemicals that are used on the lake banks, and they rotate through them.
- 18 An aquatic version of the chemical that is in Round Up is used for spot spraying. Dr. Bularzik
- 19 added that they do not overspray and the spray dries very quickly.
- 20 Mrs. Campbell from Tiger Island Estates indicated that she wished to encourage the Board to
- use safer options, and it is her personal belief that Glyphosate is toxic, and she has concern for
- the residents, pets and landscape crew. She thanked the Board for having this discussion.
- 23 Mrs. ***Dyer from Alden Woods asked what the Board will do if the majority of residents do
- not wish to have Round Up used. Mr. Campkin advised that they don't have answers on the
- 25 question yet, as they have not heard from the whole community, but they will definitely revisit
- 26 this when the winter residents return.
- 27 Mrs. Julie *** from Alden Woods shared the concerns of others as to the use of these types of
- 28 weed killers. They have seen pets get sick, and while they have no proof that Round Up caused
- it, they suspect that is the cause. She urged the Board to change to nontoxic herbicides.
- 30 Mr. Vanover noted that there is a cancer causing fear, and there is also a toxicity issue which is
- totally different. The toxicity level in Glyphosate is not very high, but the applicator must follow
- 32 the requirements on the label as far as the protection that must be worn. Those people who
- 33 are using masks are spraying something else, as some of the options offered have much higher
- 34 toxicity levels, but may be less likely to cause cancer.
- 35 Dr. Bularzik felt that it would be very important to hold a workshop this fall, as they would not
- 36 want to replace Round Up with something that could cause more problems, so research is
- 37 necessary. Mr. Vanover added that costs must be considered as well as increased protective
- equipment to be used by the applicator.

- 5 Mr. Ousley noted that the EPA report was very instrumental in making public safety the most 6 important issue.
- 7 Mr. Steve ***Barsky advised that his two dogs had cancer, which has to be more than a
- 8 coincidence. (inaudible section) He added that he didn't feel that they had to wait for the
- 9 government's opinion on this, and while the studies may not indicate any real danger,
- sometimes science lags behind, and the real truth could eventually come out.
- 11 Mr. Dorrill made two distinctions for those present, and indicated that if CDD employees are
- 12 seen spraying in the road right-of-way which includes from the back of the curb to the sidewalk,
- 13 they are primarily spraying fungicide. Tests are being done on a Round up resistant, hybrid sod
- 14 that will reduce the amount of nutrient fertilizer. Round Up is only being used on the Collier
- 15 Boulevard landscape buffer.
- 16 Mr. Dorrill also noted that his big concern, that can be addressed in the workshop, is that the
- 17 next level of herbicide available to them in lieu of Round Up would require the employee to
- 18 wear a Tyvek suit with rubber boots and gloves and a full respirator.
- 19 ***A woman spoke next, her comments were inaudible.
- 20 Mr. Drum suggested that the HOAs be asked to attend the workshop this fall, as they have a big
- say in what is used for spraying in the communities, as it is their right if the product is legal.
- 22 Most of the HOA boards have a landscaping committee, and Dr. Bularzik indicated that her HOA
- 23 Landscaping Committee was already looking at this issue.
- The residents will be advised as to when the workshop will be held, and Mr. Campkin felt that it would be later in the year.
- 26 On a MOTION by Dr. Bularzik and a second by Mr. Drum, the Board unanimously agreed to
- authorize Mr. Dorrill to check the workshop schedule for the year and coordinate some
- alternatives with the Chairman for the Board's consideration.

30 <u>C. – D. Landscape Renovation Status/Line of Credit</u>

- 31 The second submittal drawings from Mrs. Goetz' office was provided to the Board members, in
- 32 an effort to get this project bid ready. A loan application has been completed with Fifth Third
- 33 Bank for a line of credit. Mr. Pires has looked at the loan documents and made some suggested
- 34 changes that Mr. Dorrill felt were very appropriate.
- 35 These plans were for the various segments of the streetscape program, and for the benefit of
- 36 some residents who may not normally attend the meetings, Mr. Dorrill explained the contract
- 37 they had entered into with Mrs. Goetz to help rebuild portions of the streetscape that were lost
- as a result of Hurricane Irma. The replacement of Queen Palms was a particular goal, as they

- 5 did not fare well in the storm.
- 6 A workshop was held in the early spring, and the Board authorized staff to move to the next
- 7 level, which is plans and bid specifications, to put the project out to bid, and to obtain a line of
- 8 credit to spread payment over as much as ten years if the Board wished to do that. Mr. Dorrill
- 9 indicated that they would probably be able to present the loan documents to the Board at the
- 10 July meeting.
- 11 Mr. Pires noted that his changes simply clarified that the source of the funding would be a
- 12 pledge of assessments. They were also going to record a uniform commercial code, which does
- not exist in the public financing sector. What he also provided to the bank was a form of
- 14 document that he has used in other CDD transactions, and his contact at the bank will share
- 15 that with their counsel. This form makes the transaction easier, and the bank was happy with
- 16 all the changes Mr. Pires asked for.
- 17 Mr. Lee asked a question about live oaks in the portion between the sidewalk and the street on
- a section of Celeste Drive. Mr. Dorrill indicated that they can request some alternates in this
- area. Mr. Carter indicated that he had already spoken to Mrs. Goetz about this and she is in the
- 20 process of making those changes.
- 21 Mr. Drum asked if these streetscape plans were in the budget that the Board had discussed,
- and Mr. Dorrill indicated that they were, and Mrs. Goetz' estimate for this project is \$324,000.
- 23 The line of credit goes up to \$500,000. One of the other items contemplated was modernizing
- the irrigation controls, which could possibly be done with the extra amount in the line of credit.
- 25 Mr. Drum asked for clarification that the \$324,000 included the installation of the trees and
- shrubs, and was assured that this was the total bid amount. Mr. Dorrill indicated that this is
- 27 primarily a canopy and flowering tree streetscape plan.
- 28

29 E. Hurricane Follow Up

- 30 On a MOTION by *** and a second by Dr. Bularzik, the Board unanimously approved
- 31 engaging the debris engagement concept, and would require the companies to be on site and
- 32 begin work within 12 hours of a storm event to clear the primary roadways. In the event
- 33 there is no hurricane, that same dollar value work of \$5,000 each will be done to do the
- 34 annual fall tree pruning and trimming.

36 F. Parking Lot Information

- 37 Mr. Dorrill provided the design and permitting agreement with the civil engineer to add the
- 38 additional paved parking spaces to the Board for informational purposes. The total amount is

7 ATTORNEY'S REPORT

- 8 A. G. Michael MacKenzie, PA Letter
- 9 Mr. Pires advised that this letter was simply a notice of filing regarding the inventory of Mr.
- 10 Bryant's estate. This item was for informational purposes only.
- 11

12 <u>B. Falcons Glen/Encroachment Agreement</u>

- 13 Apparently a survey being done for an owner in Falcons Glen exposed two encroachments into
- 14 the Lely CDD drainage easement. There are two small concrete pads, one holding an AC
- 15 condensing unit and the other, pool equipment. The attorney for the owner sent a letter to Mr.
- 16 Pires asking for authorization that was never done originally.
- 17 Mr. Pires indicated that they are finding this issue in a number of communities within the
- 18 County, where developers would install equipment in side yards which had drainage
- 19 easements, and those were disregarded by the County. In the past year and a half the County
- 20 has begun to require more detailed site surveys to show all easements. If there is equipment to
- 21 be put on that easement, permission must be obtained from the easement holder.
- 22 If the Board is inclined to approve the placement of the equipment, an Encroachment and Non
- 23 Disturbance Agreement should be entered into between the District and the property owner
- 24 which acknowledges the improvement, and guarantees that if the pad is an impediment for the
- 25 District to repair or maintain their drainage easement, the District can remove the pad and
- 26 anything else sitting on the easement, and the landowner would be required to hold the District
- 27 harmless. Additionally, the landowner would be responsible to pay all costs associated with the
- 28 preparation and filing of this agreement.
- 29 Mr. Pires will contact the owner's counsel and advise him of what must be done, and this item
- 30 will be put on the agenda for the next meeting.
- 31

32 <u>C. Pollution Control Ordinance</u>

- 33 This item is coming before the County Commission the following week, and Mr. Pires is sending
- 34 a letter on behalf of a number of CDDs. including Lely, asking them to exclude all previously
- 35 permitted communities that have stormwater management permits with the South Florida
- 36 Water Management District, and are operating and maintaining it. There are a few issues that
- 37 would make it impossible for some communities to retrofit their systems, including available
- 38 land and the huge expense involved.

- 5 The Board then unanimously authorized Mr. Pires to write a letter to the County Commission
- 6 regarding the issue discussed above with the request for exclusion from any ordinance on a
- 7 MOTION by Dr. Bularzik and a second by Mr. Ousley.
- 8

9 FINANCIALS

- 10 The seven month financials were provided to the Board, and the balance sheet showed
- 11 \$3,800,000 in cash, part of which was fully funded reserves. Total assets, including other
- deposits or certain prepaid expenses brought the amount to \$3,846,000. Fixed capital assets
- 13 were \$10,000,000, primarily infrastructure, irrigation utility, and associated drainage facilities.
- 14 Also included was the horses monuments. There was \$10,000 in payables at that time.
- 15 The total fund balance was \$13,847,000. The income statement showed 96 percent of all
- 16 assessment revenues having been received at the end of seven months. Some additional
- 17 auction money was received but not yet noted in the financials.
- 18 Interest income was substantially more than what was originally forecast. \$7,000 was received
- the previous month, and at a little more than midyear the District has realized \$43,000. They
- 20 expect to be close to \$80,000 in interest income at the end of the year.
- 21 The second quarter CSA payment was received from Vesta and was booked during the month
- of April. The midyear actual was \$506,000. The third quarter payment has not yet been
- 23 received, and Mr. Dorrill felt that this company needed to do a better job in paying this
- 24 quarterly payment in a timely manner. Mr. Gelder has been advised of this issue.
- 25 The year-end projection for CSA income is \$100,000 over budget, a reflection of the final build
- out of the community. Arlington, the Board of County Commissioners, and the County School
- 27 Board are all billed separately.
- 28 Mr. Dorrill indicated that Mr. Carter continues to do an excellent job in keeping costs down,
- adding that the administrative cost center is over budget by \$7,000 in computer services due to
- 30 ongoing work to convert the website for the impaired. Wages were about \$40,000 under
- 31 budget due to the vacancies that occurred in the early part of the year. There are two positions
- 32 that still need to be filled.
- 33 The District is slightly over the year-to-date budget on health insurance, which Mr. Dorrill did
- 34 not feel was material at this point. Overall for total operating expenses at the end of seven
- 35 months, the District was \$143,000 under budget, fully funded on reserves, and with a very
- 36 healthy cash position.
- 37 On a MOTION by Mr. Lee and a second by Mr. Drum, the Board unanimously accepted the
- 38 seven month financials.

5 SUPERVISORS' REQUESTS

- 6 A. Community Patrol Law Enforcement Follow Up
- 7 A survey has been done on this issue, and Mr. Dorrill had it summarized and passed copies out
- 8 to the Board members.
- 9 Mr. Dorrill advised that they reached out to the Florida Wildlife Commission, who are all police
- 10 officers. As a general rule, however, they do not do special or off duty contracts work. Mr.
- Bowers indicated that if any individual officer wanted to do this type of work they are able to,
- 12 but the Wildlife Commission does not manage that work. Additionally, they do not do traffic
- 13 enforcement activities.
- 14 They also spoke to the Florida Highway Patrol, that requires an additional supervisory fee to
- 15 coordinate the off duty work schedules. Mr. Dorrill wondered if the Sheriff's Department could
- 16 work the summer months as off duty deputies, and Mr. Drum advised that it was his
- 17 understanding that the Sheriff is still having problems filling the quota of deputies they need to
- 18 cover the County, and Mr. Lee indicated that right now they are about 120 deputies
- 19 understaffed.
- 20 The Board discussed the option of hiring an additional in house security person to be on Mr.
- 21 Bowers' team, noting that unless they had an official officer or deputy, no tickets could be
- issued. Mr. Drum did not think that the amount of tickets written really warranted the money
- 23 they were paying for the Sheriff's deputies, and felt that an additional security person could
- 24 make a difference. He suggested that a recommendation be proposed and given to the Board
- 25 at the next meeting to add an additional security patrol and extra car. Mr. Bowers added that
- he does use the radar gun and it is effective. Mr. Dorrill indicated that staff would work on the
- 27 proposal for the next meeting.
- 28

29 <u>B. Roundabout at Grand Lely</u>

- 30 There are continuing problems with the roundabout at the Horse Monument on Grand Lely
- 31 with cars going the wrong way. There is an arrow in place that is misleading and has not been
- 32 removed by the County despite complaints. (Overtalk Discussion)
- 33 Mr. Pires suggested that they go to the County again on this, as it has been roughly three years
- 34 since they last asked them to remove it. As it is more of an engineering issue, he felt that the
- 35 request should come from Mr. Carter or Mr. Dorrill.
- 36

37 <u>C. 11:00 p.m. Mosquito Spraying</u>

38 Dr. Bularzik wanted those present to be aware that this spraying will take place that night.

- 5 D. Traffic Study Update/All Way Stop
- 6 This item was on the consent agenda for the Commissioners meeting a couple of weeks
- 7 previously, and it was approved with an attached budget. Dr. Bularzik asked Commissioner
- 8 Fiala's assistant when this was going to occur, and he was going to check on that.
- 9 Mr. Dorrill indicated that he heard it was imminent, perhaps this week.
- 10 A sign indicating that a stop sign is coming up will be installed to warn everyone of this change,
- 11 and the signs themselves will initially have flashing lights.
- 12 Lely will eventually replace the signs with their regular boutique style.
- 13
- 14 <u>E. Parking Lot Update</u>
- 15 This item was previously discussed.
- 16
- 17 <u>F. Post Office Box</u>
- 18 Mr. Dorrill has not yet heard about the possibility of a mail box in Lely, but he will follow up on 19 this and ask for a response.
- 20

21 G. July 10 Meeting

- 22 Dr. Bularzik reminded those present that the July meeting was going to be held a week early, on
- 23 July 10th. Mr. Dorrill will be participating via speakerphone.
- 24
- 25 <u>H. Inspira</u>
- 26 Mr. Dorrill advised that Inspira had been exempted from the Master HOA, so the District is not
- 27 eligible to bill them for CSA services as they have their own wells.
- 28

29 <u>I. Lakoya Irrigation</u>

- 30 Lakoya continues to use a large amount of water as their common areas are quite big and they
- 31 have a large number of plantings as well. All the communities pay the same for the water use,
- 32 and Mr. Dorrill indicated that in order to get them to pay a fair share, it would require sub-
- 33 metering all of the other neighborhoods and then go to a meter sale and get into utility billing.
- 34 At the inception of Lakoya, all residences were required to have an irrigation meter, and for
- 35 years the residents would have to pay the cost of installing that meter at their house.
- 36 There are submeters at both entrances of Lakoya, and if the District wished to move forward on
- this, Mr. Cole would have to prepare some estimates as to what it would cost to sub-meter the
- 38 individual neighborhoods.

- 5 Mr. Dorrill added that residents use water at Lely very freely, and Mr. Lee suggested that they
- 6 turn the water off on Thursday nights and put it back on Friday night to cut down on this use.
- 7 Mr. Dorrill suggested that staff go back and prepare some summaries of the amount of water
- 8 being purchased from the County, and the amount that the District is pumping over the past
- 9 two to three years. Mr. Lee indicated that they are pumping almost a million gallons a week, 10 which is a very high number.
- 11 Mr. Dorrill will get this information for the Board, to be looked at and discussed further once
- 12 they receive it from Mr. Cole.
- 13

14 PUBLIC COMMENT

- 15 Mrs. ***Major from the Classics asked what Mrs. Goetz charged for her services, and Mr.
- 16 Dorrill asked her to see him after the meeting so he could find that number in the general
- 17 ledger. She also asked if there was a copy of the plan on the website, and was advised that
- 18 there was not, as it has not yet been approved. Mrs. Bularzik indicated that she will give Mrs.
- 19 ***Major the one she had in her booklet so she could see what is contemplated.
- 20 Mrs. Major also noted that the Classics has been built out at 248 houses.
- 21

22 ADJOURNMENT

- 23 With a note that the July meeting would be held on the 10th, the meeting was adjourned at 3:05
- 24 p.m. on a MOTION by Mr. Drum and a second by Mr. Ousley.
