- 5 APPROVAL OF MINUTES OF FEBRUARY WORKSHOP AND REGULAR MEETING
- 6 As it relates to the workshop, Dr. Bularzik noted that her name was still not correctly spelled,
- 7 that Anne is spelled with an E.
- 8 On a MOTION by Dr. Bularzik and a second by Mr. Drum, the workshop minutes were
- 9 unanimously approved as amended.
- 10 As it relates to the regular meeting, Dr. Bularzik noted that she had prepared a letter regarding
- watering schedules and presented it to the members of the President's Council. Both she and
- 12 Mr. Carter indicated that the feedback has been excellent.
- 13 It will be up to the various presidents of Associations to work with their residents and their
- landscaping companies to make sure that they are in compliance with the schedule. After a
- brief discussion, the Board agreed that once the rainy season started, the water will continue
- 16 be turned off on Fridays.
- 17 As it relates to Page 4, Line 11, the commissioner's name is spelled Halas.
- 18 On a MOTION by Mr. Ousley and a second by Mr. Drum, the regular minutes were
- 19 unanimously approved as amended.

- 21 MANAGER'S REPORT
- 22 <u>A. Community Patrol</u>
- There were 92 incidents reported, with 11 nonresident trespassers as part of 16 total.
- 24 There was a considerable amount of suspicious activity, 20 incidents, and 28 traffic related
- incidents. There were a total of 75 traffic stops that occurred with associated warnings or
- 26 citations, and several involving accidents. Most of the traffic warnings and citations occurred
- on Wildflower. There was also some egg throwing at cars that occurred.
- 28 Mr. Drum noted that the large construction and landscaping trucks have been parking on both
- 29 sides of the roadways and causing a dangerous situation with two way traffic.
- 30 Mr. Pires suggested that in some jurisdictions a traffic plan is required, with signage in advance
- 31 of the area under construction. He suggested that this item be addressed to the County
- 32 Transportation Department to see what the requirements are when the roadway will be
- impeded in this manner. Mr. Dorrill will look into this for the Board, and report back to them
- 34 on the information he obtains.
- 35 On a MOTION by Mr. Ousley and a second by Mr. Drum, the Community Patrol report was
- 36 unanimously accepted by the Board.

- Lely Community Development District Minutes 1 2 March 18, 2020 3 Page 3 4 5 B. Streetscape Renovation Update 6 This project is on schedule and is within budget with no change orders to date. Mr. Dorrill 7 noted that the contractor is doing a very efficient job, and some supplemental manual watering 8 is being done by him as well. The irrigation system has had to be modified in certain areas as 9 well to make sure the newly planted trees are getting enough water. 10 11 C. 2020 Newsletter 12 The cover of the annual spring newsletter was provided to the Board, and it is on schedule. The 13 focus is on irrigation and conservation initiatives, and Mr. Carter and Christopher Dorrill are 14 working with Mr. Lee on it. It is anticipated that it will be sent to the printer before Easter, who 15 will mail it out once it is completed. 16 This newsletter is sent to every eligible address by geocode by the printer, and occasionally when someone does not receive a copy, it may be because their mailing address is at their 17 18 home up North. Historically 500 extra copies are made, which can be made available to those who didn't receive a copy. Several of them are also provided to the Presidents Council. 19 20 At Dr. Bularzik's suggestion, a general number for the Florida Wildlife Commission for all other animal issues other than alligators will be included on the back cover. 21 22 23 D. Field Management 24 A certain amount of assistance will be provided to Mr. Carter, including lake bank restoration 25 and the parking lot expansion through the office as Mr. Carter is very busy. 26 27 E. Irrigation Main Line Repairs The insurance policy the District carries allows them to file claims in certain instances, and a \$42,000 claim was filed after the rupture of the main line, and it was honored because it was

- 34 Mr. Pires indicated that he has more research to do on the Lady Lakes/Wentworth Estates
- 35 issue, and will bring that information to the Board at the next meeting.

- A Public Meetings/Covid-19 Issue
- 38 Mr. Pires advised that he is on the list of local government attorneys around the State, and

- 5 he is waiting to be updated on public meetings given the Covid-19 Pandemic. There are Florida
- 6 Statutory requirements to have open public meetings, and a number of local government
- 7 attorneys around the State are communicating on this issue.
- 8 Under the current laws, open meetings laws and the Sunshine Law, a quorum must be
- 9 physically present with the only exemption for participation in the meeting being due to
- 10 exceptional circumstances.
- 11 A law firm that represents a number of local governments sent a request to the Governor's
- office on March 3 asking if he would include in his declaration of emergency an exemption for
- public meetings where the public entity could conduct meetings telephonically or remotely if
- they had the means to do so. The public would also need to participate remotely by webinar,
- 15 for example. The Governor has yet to respond.
- 16 The opinions to date coming out of several cities in the State are that if there is a public
- 17 necessity, an emergency involving public health, safety and welfare, with a large issue, it would
- be possible if the governmental agency had the ability to conduct such a remote meeting.
- 19 Everyone could be given notice, and the public could be given the opportunity to at least watch
- 20 the proceedings and possibly participate.
- 21 Hopefully the Legislature will, in special session or the next legislative session, will modify the
- legislation and provide that when a state of emergency is declared, that local governments will
- 23 be able to meet electronically under the narrow circumstances of public health, safety and
- 24 welfare. Right now, absent a real public necessity involving public health, safety and welfare, a
- 25 quorum would be required by actual presence at a meeting.
- 26 Mr. Pires advised that the first floor of their building has a very large room that could
- accommodate the Board and community members while maintaining the proper distances, and
- 28 he would be more than willing to make it available to them.
- 29 Mr. Dorrill noted that unless there were some opinions received to the contrary, the next
- 30 essential thing the Board must do is to approve a tentative budget no later than June 15th.
- 31 Historically a budget workshop is done in May, and by law it must be formally approved by the
- 32 end of the summer.
- 33 Mr. Pires added that if there is a catastrophic issue, then the Chairman, the Manager and Mr.
- Carter should hire who they need to and do what they have to do on an expedited basis, and
- 35 then come back and ratify it with the Board.
- 36 Mr. Pires and Mr. Dorrill will keep the Board advised as to any decisions that come down from
- 37 the Legislature as to this issue.

FINANCIALS

- 6 At the end of the first four months of the fiscal year there was \$4,500,000 in cash, and
- 7 \$1,500,000 of that amount is in the reserve fund. Accounts payable at the end of January were
- \$ \$58,000. In response to Mr. Lee's question about the income from Arlington and Astor, Mr.
- 9 Dorrill advised that they get billed currently as part of the CSA. Mr. Dorrill will confirm that
- information for Mr. Lee. The County Commission pays their fees once they receive the annual
- 11 audited figures.
- \$151,000 in non ad valorem receipts came in during January, and year-to-date revenues
- through four months were within \$30,000 of the original forecast at \$2,100,000.
- 14 A cost of living increase was not budgeted for management fees associated with Mr. Dorrill's
- 15 contract, but the Board subsequently gave management an increase as well as a year end
- bonus. Because of those unbudgeted amounts, this line item was \$4,600 over budget.
- 17 Engineering costs were a little over budget, which was a function of lake bank restoration and
- the parking lot expansion. As a result of that, Mr. Dorrill is discussing with his accountant
- capitalizing those costs on the balance sheet so they won't flow through to the income
- 20 statement.
- In response to Mr. Lee's question about the bank charges, Mr. Dorrill advised that those were
- 22 costs attributed to the line of credit.
- 23 Year-to-date electrical charges on the water management side were over budget by about
- \$5,000, and Mr. Carter advised that it wasn't making sense to him, and that will be checked on
- 25 to determine if the numbers were correct under that line item.
- Total operating expenses year-to-date was \$60,000 below budget.
- 27 Mr. Drum asked if any new units could be anticipated, and Mr. Lee advised that there were
- 28 eight or nine more units at Cordova, which is not Stock Development, and Mr. Bowers will
- 29 check to see if that number is correct. Dr. Bularzik added that at this time they are looking for
- 30 a builder for the next building.
- 31 Mr. Drum also asked if the extra cash could be deposited into the reserves if this favorable cash
- 32 condition continues, and Mr. Dorrill agreed that this money should be applied as the Board sees
- fit, otherwise it will become a beginning balance for the general fund for the following year.
- Mr. Lee agreed, and suggested that a good use for that money would be to upgrade the control
- panel at the pump house. He added that they could raise the assessment by \$20 to \$30 and
- apply that to the control panel, and then they could begin building up their reserves again.
- 37 On a MOTION by Mr. Drum and a second by Mr. Ousley, the financials were then
- 38 unanimously accepted by the Board.

5 **SUPERVISORS' REQUESTS**

- 6 A. Saniwipes
- 7 Dr. Bularzik noted that due to the virus, more of these wipes are being used for different
- 8 purposes. When they are thrown in the toilet they get in the sewer lines and are clogging the
- 9 pumps, and they need to be disposed of in the trash.

10

- 11 B. Signs on Lely Resort Boulevard
- 12 The community identification signs on cross streets were installed by the Master Association
- and are not part of the CDD. They are in need of refurbishing, and Mr. Dorrill indicated that he
- will reach out to the Master HOA and advise that if they don't intend to maintain them, that
- 15 perhaps they should be removed.
- 16 They are in the County right-of-way, and are in very bad condition. Mr. Pires suggested that
- they call the County and advise them of this problem.

- 19 <u>C. Transportation/Triangle Boulevard</u>
- 20 Mr. Ousley advised that he had spoken to the chief engineer, who indicated that they would
- 21 have these traffic changes and corrections started in May. Mr. Lee explained the changes that
- will be made to make that area safer with easier ingress and egress to the different businesses.
- 23 It is anticipated that the work would be completed by December.

24

- 25 D. Status of Parking Lot
- The State permit was received, and the County's site improvement plan is expected shortly.
- 27 Once that is received that project will go out for quotes, which will hopefully be available to the
- 28 Board at the May meeting.

29

- 30 E. Arrow at Classics
- 31 Dr Bularzik asked if any progress had been made with the DOT on this, and apparently there has
- been none. Mr. Dorrill indicated that they met with the Department and they have evaluated
- 33 it, and they wanted to leave it the way that it is. The District is on record as expressing the
- concern they have about the misdirection of traffic, which continues to be a problem.

- 36 F. Sable Palm Planting
- 37 Mr., Campkin noted that there are so many of these palms planted on Wildflower Way, that
- they will have to change its name. Mr. Lee noted that there are 140 of these palms planted.

- 6 Mrs. Bell asked about turning the water off on Fridays, and Mr. Dorrill indicated that this
- 7 happens during the dry season as people would be in violation of the County's watering

- 9 not required. It is always turned back on for Saturday watering.
