- 5 <u>B. Role of Supervisors in HOA Turnover</u>
- 6 The date being looked at now for the turnover is March 15<sup>th</sup>, and a joint meeting will be held at
- 7 that point. Stock will hand in their resignation, and an election will be held. Three people have
- 8 put their names forward on this, including Susan Bicedomini and Ron Priestley, and a third
- 9 person as well.
- 10 Dr. Bularzik added that they are in the process of determining how the voting should be done,
- as there is nothing in the HOA documents that addresses this. Mrs. Bicedomini is working with
- 12 Richard DeBoest on these matters.
- Once the turnover occurs, it was felt that more than three people will be needed, and once the
- turnover happens, two of the three people will have to make a motion and have it carried, to
- increase the Board to seven people. Nothing has been finalized, but the process continues.
- 16 Dr. Bularzik asked about the CSA Agreement, and a copy of it will be provided to her from Mr.
- 17 Drill's office.
- 18 Mr. Lee advised that there are several items noted in the agreement that Stock is responsible
- 19 for, and he wanted to make sure that at turnover things that they know nothing about are not
- 20 turned over without disclosure. Mr. Pires was advised that the agreement is with the Master
- 21 HOA, and Mr. Pires will also look at the CSA Agreement, and added that the entity is the
- developer, and that does not change at turnover. If the obligations of the entity are not fulfilled
- at turnover, that needs to be looked at closely beforehand.
- 24 Mr. Pires will contact Mr. DeBoest on this issue as well, as there are statutory requirements
- 25 that may apply. Mr. Dorrill added that there are other issues that will be addressed as far as
- the responsibilities of the CDD once the turnover is completed.
- 27 Dr. Bularzik advised that the question about the money that was missing from the budget
- 28 related to fees has been put back in. She also asked Mr. Pires if a member of the CDD Board
- 29 could sit on the new HOA Board, and Mr. Pires will check on that in the Statute and provide
- some information on it, as there are several issues that could come into play.
- 31 He added that the only official opinion on the Ethics Code would have to come from the Florida
- 32 Commission on Ethics, and he will check with Chris Anderson who sits on that Ethics
- 33 Commission.
- 34 The issue of what the CDD can and cannot contribute to as it relates to spending money, as all
- 35 CDD money has to be spent on public purpose activities, was discussed. If the Master indicated
- that there were certain activities that they no longer wished to engage in, those things would
- 37 have to be looked at as well. Further discussions will be had on these items as more
- information is brought to the Board.

Lely Community Development District - Minutes 1 2 December 16, 2020 3 Page 4 4 5 Dr. Bularzik expressed a concern about the Master opting to do some landscaping work along 6 the roadways which may not be in keeping with what has been done before turnover, and Mr. 7 Pires noted that they would have to get a permit from the County to do any work of this nature, 8 and the District could go to the County and address this. 9 10 C. Health issues with Staff Employees In response to Dr. Bularzik's question, Mr. Carter indicated that four employees had the COVID 11 virus, and three of them were back at work after recovering from two to three weeks, and all 12 are doing well and testing negative. The fourth employee was in the hospital for three weeks 13 14 and has now been released. He is recovering at home now and Mr. Carter hopes to see him 15 back at Lely when he is strong enough to resume work. 16 17 D.
