19	WORKSHOP - LANDSCAPE ENHANCEMENTS
20 21 22 23 24 25 26	This landscape enhancement work typically represented canopy trees in the last two phases. This is phase three. The first phase was along the Boulevard, the second phase was along Celeste. The intent of the workshop today is to highlight areas on the Boulevard that were passed over in the first go-around and any additional areas that the Board may desire. The landscape architect for the community is Ellin Goetz. She is an award-winning landscape architect who was instrumental in the creation of the Naples Botanical Garden.
27 28	One of the historical problems of the Boulevard is the width of it. There is a lot of grass in that area and a subsurface soil condition that tends to hold a lot of water. As a result,

- 1 there have been areas of sod and the original canopy oak trees that have not as done
- well as they should have because of the accumulation of ground water.
- 3 Mr. Carter said that when they did some replanting after Hurricane Irma along Lely
- 4 Resort Boulevard there were two center medians that were kept wide open as a vista;
- 5 they did not get any trees. The first median is basically between Mustang Dr to Indian
- 6 Wells (just has the existing oak trees) and the second is from Indians Wells to Falcons
- 7 Glenn. They are two adjacent center medians that did not get anything planted
- 8 according to Ms. Goetz's planting plans that the Board approved in the past. She has
- 9 given them ideas of what to place in there now.
- 10 For the first one, Ms. Goetz suggested four canopy trees. For the second one she
- 11 recommended planting six canopy trees along with smaller trees. Ms. Goetz came out
- and evaluated what trees seem to do the best in the area. Mr. Carter said they have had
- some issues with the smaller trees. Many tend to blow or lean when there are high
- winds or storms. He said they still have straps on ones that were planted five years ago.
- 15 The most favored canopy tree was found to be the Royal Poinciana. Mr. Carter said that
- one of them in each of those medians would look great. He noted that Ms. Goetz is a
- big advocate for the Gumbo Limbo tree as a secondary canopy tree in the medians. If
- 18 they are going to accent with smaller trees the ones that have done the best are the
- 19 ligustrum trees. Mr. Carter said the silver buttonwood trees look very similar to the
- 20 ligustrum. Those were the suggestions from Ms. Goetz for those two medians. Mr.
- 21 Carter said if there are any other medians on Lely Resort Blvd that are getting a lot of
- 22 wind and the trees are constantly having to be trimmed back, it would be a good idea to
- consider replacing them with the ligustrum or silver buttonwood trees.
- 24 Mr. Carter said a lot of the trees that have been planted have not flourished because of
- 25 the soil. He said some of them have not grown to the level they would like to see after
- 26 five years. Ms. Goetz did a small, ancillary study with reasons why/what may be wrong.
- 27 In the past it was determined that there are drainage issues because of the lime rock
- soil. Ms. Goetz is recommending that to plant the new trees, they need to go about six
- 29 feet deep and add in 57 stone to help it drain. The 57 stone would then be covered with
- 30 topsoil. Ms. Goetz provided a planting plan that the landscaper would use to plant these
- 31 new trees. The live oaks that are in the medians will be left alone. Mr. Dorrill said there
- 32 is enough area in the center medians that they do not encounter the issues that the
- 33 single-family neighborhoods may with those trees (driveway and sidewalk root
- 34 upheaval).

- 1 \$42,000 was put in the budget in anticipation of this work. There are more than
- 2 adequate additional reserves if needed. Mr. Dorrill thinks Ms. Goetz should be asked
- 3 about recommendations for container size. Mr. Drum asked if anything was going to be
- 4 done on Triangle Boulevard. He said that he thinks the traffic loop is great on that street,
- 5 but he said all you see is the traffic. He said right now it is bare, but he is not sure how
- 6 much landscaping you could add without blocking sight lines and such. Mr. Lee said
- 7 that was all dictated by the County. The CDD is only going to maintain what is there
- 8 right now.
- 9 Mr. Dorrill said that the next step is to tell Ms. Goetz they like her suggestions and ask
- 10 her to prepare technical specifications to describe the planting concepts and container
- 11 size/field grown product. Mr. Dorrill may ask Ms. Goetz to coordinate the solicitation of
- 12 bids/proposals and bring them back perhaps as early as next month for discussion at
- the regular meeting. Ms. Goetz will be at that meeting to make the recommendation.
- 14 Dr. Bularzik asked if there is any impact or issues with Lely Master Association. Mr.
- Dorrill said that this is all County property so architectural controls would not come into
- play here. Mr. Drum asked about the Queen Palms on Celeste that were lost. Ms. Goetz
- is not a fan of Queen Palms. Mr. Dorrill shared that they have not been replanted
- because they are very susceptible to tropical storm force winds and are magnets for a
- 19 contagious fungal disease. They are not native and are very diseased prone. Mr. Drum
- asked how the Foxtail Palms are doing. Mr. Carter said they are doing well. Mr. Dorrill
- said they will have Ms. Goetz onsite to look this month and see if any areas warrant the
- 22 Board's consideration for enhancement that can then be budgeted for next fiscal year.
