## 1 WORKSHOP - HURRICANE PREPARDNESS

2 Mr. Carter shared information from the National Hurricane Center's report, predicting an

- 3 above-normal 2024 hurricane season with expectations of 8 to 13 hurricanes and 4 to 7
- 4 major hurricanes (Category 3 and above). The forecast suggests a transition to La Niña
- 5 conditions, typically associated with increased hurricane activity.
- 6 Preparations for hurricane season include ongoing tree trimming, with current focus on
- 7 completing work on queen palms. In anticipation of potential storms, Mr. Carter and staff
- 8 ensure the gas tanks are full, as fuel availability tends to decrease during storms. All
- 9 vehicles, including trucks, patrol cars, and utility vehicles get filled up. Additional
- 10 supplies such as chain saws (stored without oil and gas), spark plugs, 2x4s, banding
- 11 material for trees, and tree stakes are also acquired.
- 12 As a hurricane warning is issued, Mr. Carter and the staff prepare chain saws and start
- 13 them up. They gather 2x4s, banding material for trees, and tree stakes. They ensure the
- 14 generator has plenty of fuel, which has already been done. They also check that they
- 15 have flashlights and batteries. Patrol cars are equipped with cameras so drive through
- 16 after the storm and ensure footage of every street is captured. Staff has a large first aid
- 17 kit designated for hurricane season, and they ensure that everything susceptible to
- 18 blowing away at the maintenance facility is securely tied down. They have ample 5-
- 19 gallon containers for diesel and regular gas on hand. They have a pallet of water onsite
- 20 for staff. The pump station is turned off completely the night before the hurricane. They
- also turn off the fountain and lights at the horse monument and take down American
- flags. Mr. Carter holds a meeting with staff and community patrol to ensure they can
- return as soon as it is safe. He commended the staff, sharing that the day after
- 24 Hurricane Irma, 15 out of 17 maintenance staff members returned to work.
- 25 The District has an eight-year-old propane generator for the maintenance building that
- 26 Mr. Dorrill would like to replace before it malfunctions. The current generator, if
- 27 replaced, could be sold at a surplus auction or kept as a backup. Mr. Dorrill also
- 28 proposed acquiring appropriate canned food for staff in case they need to stay onsite,
- 29 instead of just relying on protein bars and other snacks. Mr. Fox suggested installing a
- 30 small freezer stocked with items such as frozen burritos, hamburgers, and sausage
- 31 biscuits. Mr. Pires asked Mr. Dorrill if there is a resolution in place authorizing the
- 32 manager to make emergency purchases. Mr. Dorrill said if Mr. Pires has one that he
- can evaluate he would be happy to present it to the Board.
